SUBMISSION INSTRUCTIONS, REVIEW PROCESS AND ACCEPTANCE NOTIFICATION

The DUE DATE or “window” for the acceptance of submissions is from NOVEMBER 1st of current year until JANUARY 31st of the following year for the year of nomination. The form should be filled out to the best of the nominator’s ability and emails to dragonsdenboone@gmail.com with the SUBJECT header/line being “Challenge Coin nomination” so that it will be noticed and not filtered out. Any delays or extensions of this deadline will be announced via Dragon’s Den social media pages or site.

Should the nominee be accepted then the nominator will be notified so that they can contact the nominee and inform them that will be a recipient of this coin. It is the responsibility of the nominator as the sort of POC for the nominee to inform the nominee when and where they coin ceremony will be held. The store or coin committee will announce via social media this information as well. The coin ceremony will be held or the coin will be given to the recipient whenever their schedule allows. Then we all rejoice. Lastly, a picture and the name of recipient will be added to our Coin Challenge Hall of Fame that will be published on our website or at the store.

GUIDELINES & RESTRICTIONS

Please observe the following **MINIMUM requirements** expected for the issue of the coin, any category that is not satisfied will result in immediate disqualification of the nominee:

1. Anyone that is **not a current owner** of the Dragon’s Den.
2. Anyone that is **not already inducted** into the current Coin Hall of Fame.
3. Anyone that is from: **Watauga, Ashe, Wilkes, Avery, and Alleghany**.
4. Anyone that is **not banned from the Dragon’s Den** or any other affiliates.
5. Anyone that is **not currently a felon** (*within last 10 years*) or **currently on a registry**.
6. Anyone that is **not** on the store **BOLO list** for suspicion of trading **stolen goods**.
7. Anyone that is **not** on the store **BOLO list** for other **suspicious activity**.
8. Anyone that is **not** under the **age of 18**. Adults only, please.
9. Anyone that has **not** engaged in any malicious activity **against the store**.
10. Anyone that does **not** own/employed with **any entity currently banned by the store**.

Please note the following other considerations when nominating your nominee:

1. **FAILURE** to note any exceptions to the above guidelines will result in the nomination being declined, should any information be discovered after the fact.
2. **WAIVERS** can be provided to most of the guidelines above on a case-by-case basis, but will require further justification from the nominator in writing. There are no exceptions or waivers for the rule regarding felons and those on a registry. End of discussion.
3. **REVOCAION** can occur at any time for any reason by the current admin, manager, or owner of the Dragon’s Den. Namely this will happen should that person openly engage in malicious activity against the store or those employed therein. In short, continue to be nice and do not let the coin go to your head or do something that results in a loss of face with the owners of the store. Use common sense and your brain.
4. **EXPLANATION** of how or why a person was not accepted for the reception of a coin is purely at the sole discretion of the coin committee members to protect the privacy of individuals and the prevention of needless drama that might result in civic issue.
